The Township was awarded the WCWS Wetlands Project grant. This project is the first of its kind in Southwest Ohio and has an estimated timeframe of 3 years. The bidding on the project will be in November 2024, with construction slated to begin in early Spring of 2025. Hunter Park has received over \$700,000 in improvements over the last 2 years, and the new Wetlands Project grant will add more to Hunter Park for the community to enjoy.
