**Administrator's Report:**

The tennis/pickleball court striping at Hunter Park was completed. The nets will be put back in the next couple of days and ready for use. He was able to visit the park during the day and enjoyed seeing the community utilizing the park.

The foundation for the columbarium at Woodhill Cemetery has been poured & the gravel has been spread. The first shipment is set to arrive in the next couple of weeks. Once installed, then niches will be available for purchase.

Both the First Aid cabinet and mobile units have arrived and been installed for the Road Department. The Cemetery Department's units will be arriving soon. The now mandatory stationery & mobile AED units will be arriving within the next couple of weeks. They will be placed at the concession stand at Hunter Park, Woodhill Cemetery, and a mobile unit for the Road Department.

There will be a Franklin Township Comprehensive Plan Work Session meeting on November 13<sup>th</sup>, 2024. It is the last stage of review before the plan will be presented to the board for voting.

The salary budget for 2025 year will be discussed either at the second trustee meeting in November 2025 or the meeting in December 2025.
